Our benchmark Decision Rules for Contracts, 12-mo. index, modeled at [www.e-markets.com](http://www.e-markets.com), is a daily futures price less 20¢ basis, Oct. 1 (year before harvest) through Sept. 30 of the crop year; 9-mo. index is Jan. 1 through Sept. 30 of crop year. Market value is the best indicator of adviser performance to compare to the benchmarks. It reflects (1) the Central Illinois cash price received on crop sold, (2) price on the unsold balance on the report date, and (3) futures and options profits and losses. Track Records do not include loan deficiency payments or marketing loan gains, which may substantially change the results.
